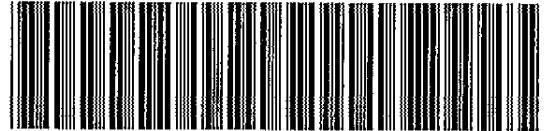


Our firm changed the name from Prugh, Holliday & Deem, P.L. to Prugh, Holliday, Deem & Karatinos, P.L.
