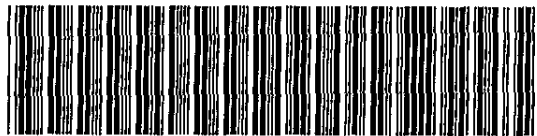




FIRST: The Articles of Organization were filed on December 29, 2000, and were assigned document number L01000000130, effective January 1, 2001.
