


ARTICLE VII-Miscellaneous

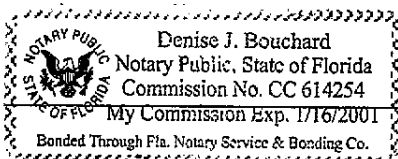
