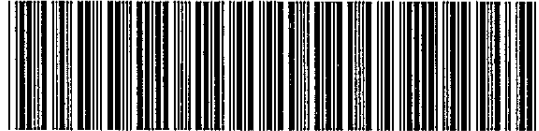

Pursuant to the provisions of section 608.411, Florida Statutes, this Florida profit limited liability company adopts the following amendments to its Articles of Organization which were filed with the Department of State on January 2, 2001:

ARTICLE I: The name of the limited liability company (which may sometimes hereafter be referred to as the "Company") is changed to
