## A PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, who is a duly licensed real estate broker in the State of Florida and desiring to form a professional limited liability company in accordance with the Florida Limited Liability Company Act and the Florida Professional Service Corporation and Limited Liability Company Act, does hereby adopt the following Articles of Organization for the Limited Liability Company:
