ARTICLES OF ORGANIZATION

SECOND: The period of duration for the Limited Liability Company shall be perpetual.

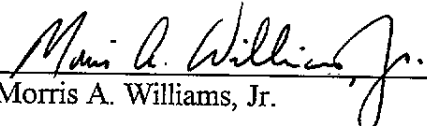
THIRD: The Limited Liability Company is organized for the purpose of performing the services of a real estate broker and to take all actions that are necessary or proper in connection with such services.

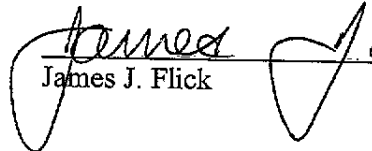
