



#### **ARTICLE V - Admission of New Members**

#### **ARTICLE VI - Continued Business upon Death of Member**

The remaining Class "A" Members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminated the continued membership of a Member in the Company. The business may be continued only on the unanimous written consent of the remaining Class "A" Members.

#### **ARTICLE VII - Additional Provisions**


The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the Class "A" Members listed in Article IV.
