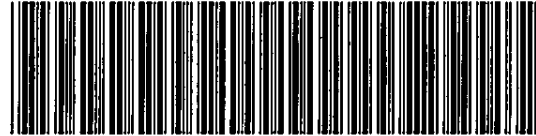

The Law Office of Tim Moran, L.C. has distributed all remaining property and assets to the member, Tim Moran, in accord with his rights and interests.


There is no suit pending against the limited liability company in any court.
