Articles IV and V of the Articles of Organization of Interamerican Advanced Communication Services, LLC, were amended by the company's members on the 4th day of January 2002. 1. The name of the company is Interamerican Advanced Communication Services, LLC.
2. The Articles of Organization of Interamerican Advanced Communication Services, LLC, were filed on January 9, 2001.
3. Article IV of the Articles of Organization of Interamerican Advanced Communication Services, LLC, is amended and, hereinafter, provides as follows:

4. Article V of the Articles of Organization of Interamerican Advanced Communication Services, LLC, is deleted.
