ARTICLES OF ORGANIZATION
OF
JACARANDA ASSOCIATES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be JACARANDA ASSOCIATES, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company shall be 3714 Cadbury Circle, Venice, Florida 34293.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- TERMINATION OF EXISTENCE

The Company shall be dissolved and its business shall terminate upon the earliest occurrence of any of the following events:

(a) delivery to the Managers of a written agreement in which all Members approve of the termination of the Company;

(b) the sale, exchange, forfeiture or other disposition of all or substantially all the assets of the Company unless all Members agree otherwise; and

(c) any event described in Section 608.441, Florida Statutes (or successor provision thereof) for a limited liability company with perpetual life.

The Company shall continue to exist after the happening of any of the foregoing events solely for the purpose of winding up its affairs in accordance with the Florida Limited Liability Company Act.
