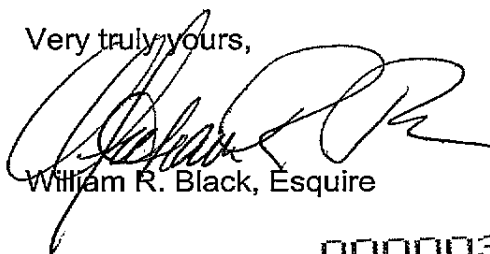

ARTICLES OF ORGANIZATION

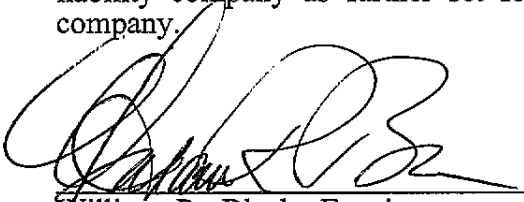

8. Additional Members. The names and addresses of additional members(s) are as follows: None.

9. Admission of New Members. With the written unanimous consent of the members, new members may be admitted into the LLC upon the payment of such capital contribution and upon such terms as the members unanimously decide. In order to qualify as a new member, the new member must be a member in good standing of the Florida Bar, a member of the National Network of Estate Planning Attorneys and a member of Lifespan™ Legal Services, LLC.
