The Limited Liability Company shall not be dissolved by the death, retirement, resignation, expulsion,

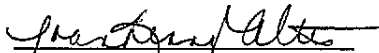

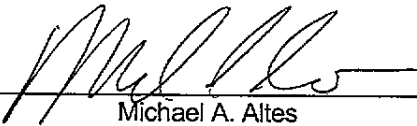
