#### ARTICLES OF ORGANIZATION FOR CHITTENDEN ENTERPRISES, LLC, A FLORIDA LIMITED LIABILITY COMPANY

In order to form a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, the undersigned members hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I. NAME

The name of the limited liability company is CHITTENDEN ENTERPRISES, LLC ("Company").
