#### ARTICLES OF ORGANIZATION OF PELICAN PROPERTIES, LLC

The undersigned, as the Managers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida limited liability company (this "Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles"):

#### ARTICLE I Name

The name of this Company shall be: PELICAN PROPERTIES, LLC.

## ARTICLE II

Commencement Date and Duration

This Company shall commence on the date of subscription and acknowledgment in accordance with the provisions of Section 608.409(3)(a) of the Act, and shall continue for period of fifty (50) years from the commencement date, or until dissolved by its members or manager in accordance with Section 608.441 of the Act or the provisions of these Articles. Subject to the foregoing, this Company shall be dissolved on the happening of any of the following events:

- Expiration of the term specified above; 1.
- Withdrawal, retirement, death, resignation, bankruptcy, dissolution or 2. expulsion of any member, unless the business of this Company is continued by the consent of all the remaining members; or
  - Unanimous written consent of all of the members. 3.

#### ARTICLE III Place of Business
