ARTICLES OF ORGANIZATION  
OF

The undersigned person, acting as the organizer of MEDITERRANEAN VILLAGE, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), adopts the following Articles of Organization:

ARTICLE I - NAME

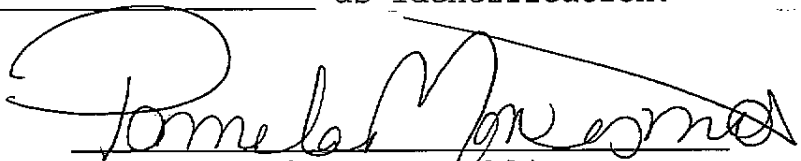
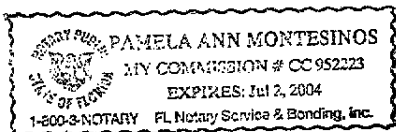

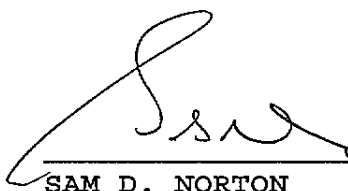
