ARTICLES OF ORGANIZATION OF CENTER PROPERTIES-LAKE ST. CHARLES MEDICAL CENTER, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The principal and mailing address of the principal office of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 101 E. ARTICLE VII

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
