**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
ALTERNATIVE REAGENT SOURCE, LLC  
(A Florida Limited Liability Company)**

FIRST: The date of filing the articles of organization was January 17, 2001.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

6. Termination of Membership.

- (a) A member may withdraw or resign at any time prior to the dissolution and winding up by giving written notice to the remaining members and said interest may be assigned to an existing or new member by a vote of the majority-in-interest of the members who consent in writing to the withdrawal or resignation of the withdrawing member. The resignation of any member shall take effect upon receipt of notice thereof or at such later time as shall be specified in such notice.
- (b) If a member of the Company dies, retires, withdraws, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.
