

**ARTICLES OF ORGANIZATION  
REW TRUCKING, LLC**

**ARTICLE I. – NAME**

The name of this Limited Liability Company is “REW Trucking, LLC.” It is referred to in these Articles of Organization as the “Company.”

Management of the Company is vested in the members in accordance with these Articles, or such operating agreement agreed to by the members of the Company, or the Florida Limited Liability Company Act.


**ARTICLE V. – EFFECTIVE DATE**

The effective date of its organization shall be the filing of the Articles of Organization.


