
ARTICLE V - MANAGEMENT

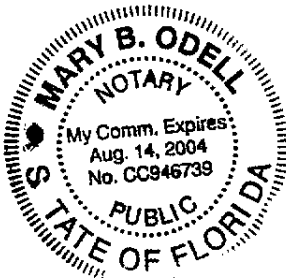
