AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

PARROT RIVER TRADING COMPANY, LC

The undersigned being a Member of PARROT RIVER TRADING COMPANY, LC, a limited liability company organized under the laws of the State of Florida on January 19, 2001 (the "Company"), desiring to amend and restate the Articles of Organization of the Company pursuant to the provisions of Chapter §608 of the Florida Limited Liability Company Act, Florida Statutes does hereby adopt the following Amended and Restated Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is PARROT RIVER TRADING COMPANY, LC (the "Company").

ARTICLE II

ADDRESS

The principal office and mailing address of the Company is:

ARTICLE III

REGISTERED AGENT AND OFFICE

The Company designates 701 Brickell Ave., Suite 3000, Miami, Florida 33131 as the street address of the registered office of the Company and names Intrastate Registered Agent Corporation as the Company's registered agent at that address to accept service of process within this state.

ARTICLE IV

MANAGEMENT

The Company shall be conducted, carried on, and managed by at least one (1) Manager. The Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company. The Manager(s) shall serve in such capacity until their successor(s) are duly elected and qualified.

ARTICLE V. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, of (ii) by the written agreement of a majority of ownership interest.

ARTICLE VI. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VII. ADDITIONAL MEMBERS/CAPITAL

Additional Members may be admitted with the consent of the Managers for such consideration as the Managers shall determine, without the need to offer preemptive rights or proportionate participation to existing Members. Additional contributed capital raised from existing Members may only be raised pursuant to Section 3.2 (or any successor provision) of the Operating Agreement.

ARTICLE VIII. AMENDMENTS TO OPERATING AGREEMENT/ARTICLES OF ORGANIZATION

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company in the manner set forth in the Operating Agreement of the Company. Any alteration or amendment to these Amended and Restated Articles of Organization shall require the affirmative vote of 75% of membership units then outstanding.
