FIRST: The name of the Limited Liability Company is: Whidden Family L.L.C.

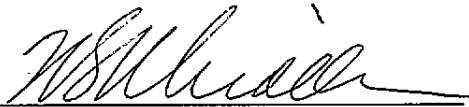

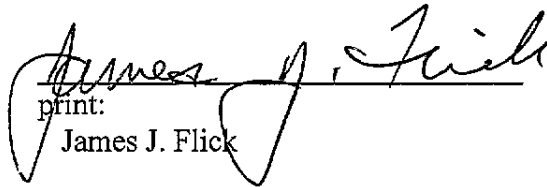
CONSENT TO APPOINTMENT
