

FOR

ARTICLE I - Name

The name of this limited liability company shall be N B W FARMS, LLC.

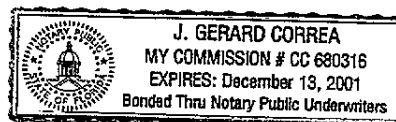


