Articles of Organization for FloraSource, LLC

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

FIRST: The name of the limited liability company (hereinafter referred to as the "Company") is "FloraSource, LLC".

SECOND: The latest date on which the Company is to dissolve is December 31, 2050.

THIRD: The purposes for which the Company is formed are:

To have and exercise any and all the power and authority conferred upon a limited liability company by Florida law including but not limited to the powers granted under Chapter 608 Section 608.404 of Title XXXVI of the Laws of Florida except as restricted by the Operating Agreement of the Limited Liability Company, or any agreement among the members authorized by the provisions of Florida law relating to a Limited Liability Company.

FOURTH: ^{Street and mailing} The address of the principal office of the Company in the state of Florida is 260 Lock Rd, Deerfield Beach, Florida 33442.

FIFTH: The name and address of the resident agent of the Company is Steve Spector, whose address is 260 Lock Rd, Deerfield Beach, Florida 33442. Said resident is a citizen of the State of Florida and actually resides therein.

SIXTH: No member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to act for the Company solely by virtue of being a member.

EIGHT: The Company will be managed by the Member named as Managing Member in the Operating Agreement; the Operating Agreement may only be amended by the unanimous agreement in writing of all members.

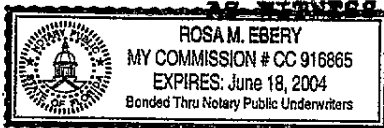

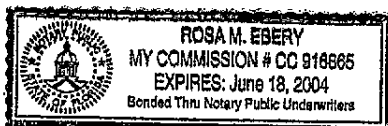


