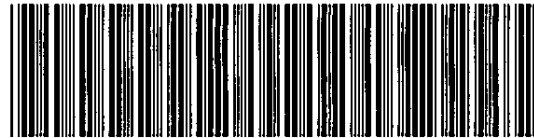



**FOURTH AMENDMENT TOP ARTICLES OF ORGANIZATION  
OF
