**ARTICLES OF ORGANIZATION OF
IMAGINATION, LC**

1. Name. The name of the limited liability company (hereinafter "company") is: IMAGINATION, LC.
2. Existence. The company shall have perpetual existence. The company shall commence existence on January 18, 2001.
3. Location. The street address of the principal office of the company is 2706 SW 34th Street, Gainesville, FL 32608. The mailing address of the company is 2706 SW 34th Street, Gainesville, FL 32608.
