## ARTICLES OF ORGANIZATION OF <a href="magination">IMAGINATION</a>, LC

- 1. Name. The name of the limited liability company (hereinafter "company") is: IMAGINATION, LC.
- 2. Existence. The company shall have perpetual existence. The company shall commence existence on January 18, 2001.
