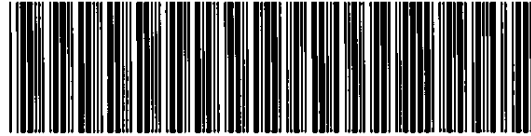

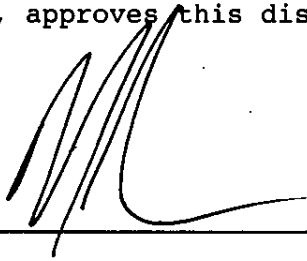
At a meeting of 2631 N.W. 1st Avenue LLC held May 9, 2006, for which notice was waived and at which all members were present, the following action was approved unanimously:

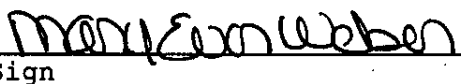
There are no suits pending against the company in any court.
