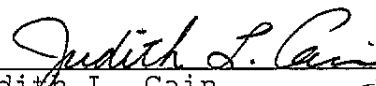

**ARTICLES OF ORGANIZATION OF

1. Name. The name of the limited liability company (hereinafter "company") is: CAIN HOLDINGS, LC.
2. Existence. The company shall have perpetual existence. The company shall commence existence on January 19, 2001.
