ARTICLES OF ORGANIZATION OF
WILLIAM L. EWELL, JR., ATTORNEY, PLC

The undersigned, William L. Ewell, Jr., Sarasota, Florida, acting as authorized representative of WILLIAM L. EWELL, JR., ATTORNEY, PLC, for the purpose of forming a professional limited liability company under the Florida Business Organizations Act, 2000, adopts the following articles of organization:

ARTICLE I

NAME

The name of the professional limited liability company, hereafter referred to as the "PLC" is:

ARTICLE II

PURPOSE
