ARTICLES OF ORGANIZATION

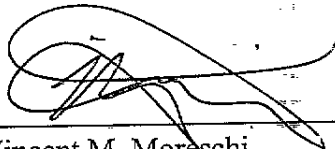
ARTICLE VIII: MANAGEMENT

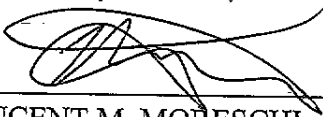
