All debts, obligations and liabilities of the limited liability company have been paid or discharged, or adequately provided for pursuant to Section 608.4421, Florida Statutes.


ARTICLE IV


All remaining property and assets of the limited liability company have been distributed among its members in accordance with their respective rights and interests.
