**ARTICLE VII - MANAGEMENT**

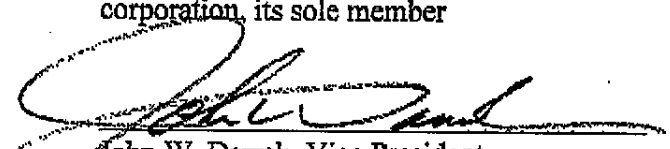
