OF

**ARTICLE I
NAME**

The name of the limited liability company is Florida Institute of Complementary Medicine, LLC (the "Company").

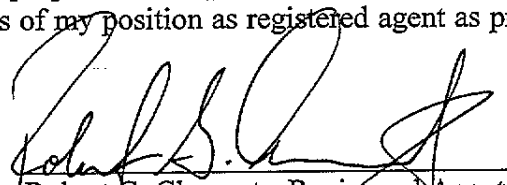
**ARTICLE IV

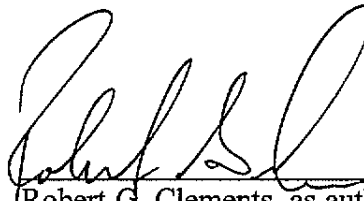
ARTICLE VIII
