## ARTICLES OF ORGANIZATION OF FLORIDA INSTITUTE OF COMPLEMENTARY MEDICINE, LLC

#### ARTICLE I NAME

The name of the limited liability company is Florida Institute of Complementary Medicine, LLC (the "Company").
