# **ARTICLES OF ORGANIZATION**

## **OF**

### **LTJ GROUP III, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be LTJ Group III, L.L.C. ("Company").

#### **ARTICLE II - PURPOSE AND POWER**




