ARTICLES OF ORGANIZATION

OF

ROSLYN G. PECHET INTERIOR DESIGN, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby, makes, acknowledges, and files the following Articles of Organization.

ARTICLE I-NAME

The name of the limited liability company shall be ROSLYN G. PECHET INTERIOR DESIGN, LLC. ("Company").

ARTICLE II-ADDRESS
