ARTICLES OF ORGANIZATION

OF

CARBON PRESS, L.C.

(A Florida Limited Liability Company)

The undersigned adopts the following Articles of Organization for the purpose of becoming a Limited Liability Company under the Florida Limited Liability Company Act, and adopts the following as its Articles of Organization:

1. Name. The name of the limited liability company referred to in these Articles as "Company," is:

2. Purpose. The purpose for which the Company is organized is to engage in any or all lawful acts, activities or lawful businesses which limited liability companies may engage in under the laws of the State of Florida or under any other jurisdiction in which the Company may conduct business.
