(A Florida Limited Liability Company)

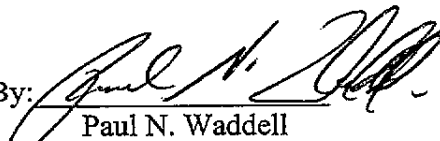
**FIRST:** The date of filing the Articles of Organization was January 31, 2001.

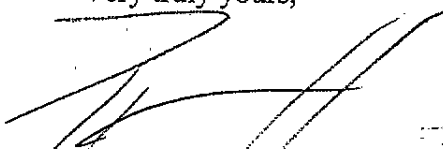
