## ARTICLES OF ORGANIZATION FOR AMIGO VENTURES SOUTH, LLC

### ARTICLE I - NAME

The name of the limited liability company is Amigo Ventures South, LLC ("Amigo").

### <u>ARTICLE II - ADDRESS</u>

## **ARTICLE III - DURATION**
