ARTICLE III - DURATION

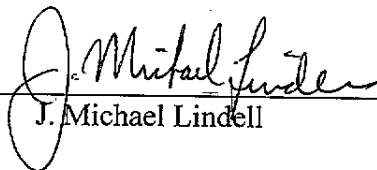
The period of duration for Amigo shall be perpetual commencing with the filing of these Articles of Organization.
