**ARTICLE I**  
**NAME**

The name of this limited liability company is CY & Q MANUFACTURING, LLC.

**ARTICLE II**  
**DURATION**

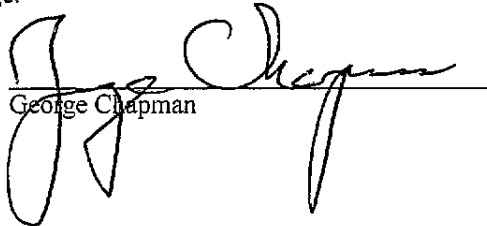
ARTICLE IX

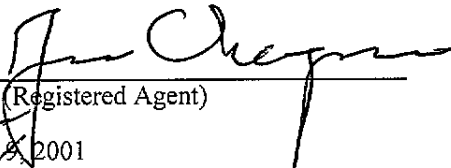
