# **ARTICLES OF ORGANIZATION**

## **OF**

### **CROSSROADS COMMERCIAL BUILDING SERVICES LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **CROSSROADS COMMERCIAL BUILDING SERVICES LLC**, ("Company").

#### **ARTICLE 2 - ADDRESS**

#### **ARTICLE 3 - EFFECTIVE DATE**

The general purpose for which the Company is organized is to engage in commercial building maintenance and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

## **ARTICLE 9 - TERMINATION OF EXISTENCE**

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.




