### ARTICLES OF ORGANIZATION

#### OF

## CHILDREN'S ORTHOPEDICS OF SOUTHWEST FLORIDA, LLC

- 1. Name. The name of this limited liability company is CHILDREN'S ORTHOPEDICS OF SOUTHWEST FLORIDA, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
