ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 – NAME

The name of the limited liability company shall be **MAIN STREAM DEVELOPMENT GROUP, L.L.C.**, ("Company").

ARTICLE 2 – ADDRESS

The principal place of business of the Company in Florida shall be 5148 Palangos Drive, Punta Gorda, Florida 33982 and the mailing address shall be the same.

ARTICLE 9 – TERMINATION OF EXISTENCE
