AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF POSSESSIONS, LLC

The undersigned, for the purpose of amending and restating in its entirety the original Articles of Organization of POSSESSIONS, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization pursuant to the provisions of Section 608.411 Florida Statutes.

ARTICLE I -- NAME

The name of the limited liability company shall be POSSESSIONS, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the initial principal office of the Company shall be 5201 Tamiami Trail North, Naples, Florida 34103.

ARTICLE III -- DURATION

The Company commenced its existence on February 6, 2001, which is the date that the original Articles of Organization were filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

The Company shall be dissolved upon the occurrence of events specified in the Company's
