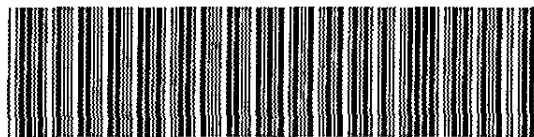

1. The present name of the Company is HOMEBUILDERS MORTGAGE NETWORK, LLC, a Florida limited liability company.

ACCORDINGLY, these Articles of Amendment were executed on April 1, 2003.

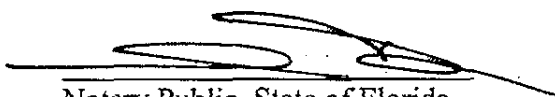
