ARTICLES OF ORGANIZATION
OF
NATIONAL NETWORK SERVICES GROUP, LLC
(a Florida Limited Liability Company)

THE UNDERSIGNED, hereby executes these Articles of Organization for the purpose of becoming a Limited Liability Company under the Florida Limited Liability Company Act.

Article I - Name

The name of this limited liability company referred to in these articles as "Company" is

Article V - MANAGEMENT




