ARTICLE I


ARTICLE VI

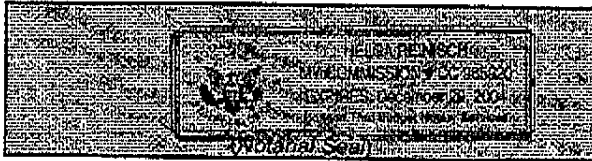


