ARTICLES OF ORGANIZATION

These Articles of Organization are being executed as of the 7th day of February, 2001, for the purpose of forming a Limited Liability Company, pursuant to the Florida Limited Liability Company Act.

The undersigned, being duly authorized to execute and file these Articles, hereby certifies as follows:

ARTICLE I - Name:

The name of the Limited Liability Company is: **GARNER WINDOW & DOOR, LLC.**

ARTICLE II - Address:

ARTICLE III - Registered Agent, Registered Office:




