**ARTICLES OF ORGANIZATION**

**ARTICLE I - NAME**

The name of this limited liability company shall be SELF INSURED MANAGEMENT COMPANY OF FLORIDA, LLC.

**ARTICLE II - DURATION**

The limited liability company shall have perpetual existence.

#### ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS




